AMA, state and county medical society medical association members and their families are eligible. Complete an AMPAC contribution form along with your Capitol Club contribution. Capitol Club Platinum donors (eligible members/residents/students) will receive five sweepstakes entries. Capitol Club Gold donors (eligible members/residents/ students) will receive two sweepstakes entries, and Capitol Club Silver donors (eligible members/residents/students) will receive one sweepstakes entry.

AMPAC is a separate segregated fund established by the AMA. Voluntary political contributions by individuals to AMPAC should be written on personal checks or provided on a personal credit card. Funds from corporations cannot be used for contributions and expenditures in Federal elections. Corporate contributions will be placed in a separate AMA account for political education and other non-election activities. Contributions are not limited to the suggested amount. Neither AMA nor its constituent state associations will favor or disadvantage anyone based upon the amounts of or failure to make PAC contributions. Voluntary political contributions are subject to limitations of the FEC regulations. Contributions to AMPAC are not deductible for federal income tax purposes.

OFFICIAL SWEEPSTAKES RULES

American Medical Political Action Committee ("Sponsor") | AMPAC's 60th Anniversary Celebration Giveaway ("Sweepstakes")

- The American Medical Political Action Committee ("AMPAC")-sponsored Sweepstakes is open to (a) 2021 AMPAC donors who have made Qualifying Donations and (b) members of the Restricted Class (defined in this section 1 below) who submit an index card as described below. Qualifying Donations are those contributions to the AMPAC Fund for the 2021 membership year delivered to a designated AMPAC agent in the Washington, DC Headquarters by 5:00 p.m. Eastern Time, Friday, November 5, 2021 ("Deadline"). Sweepstakes entries shall be allocated as follows:
 - Non-resident/non-medical student members of the Restricted Class who made Qualifying Donations shall receive one (1) Sweepstakes entry for each \$500 contribution increment.
 - Resident/medical student members of the Restricted Class who made Qualifying Donations shall receive one (1) Sweepstakes entry for each \$250 contribution increment.
 - Capitol Club Platinum Donors are (a) those non-resident/non-medical student members of the Restricted Class who made a minimum Qualifying Donation of two thousand five hundred dollars (\$2,500) for the 2021 membership year; and (b) those resident/medical student members of the Restricted Class who made a minimum Qualifying Donation of one thousand two hundred fifty dollars (\$1,250) for the 2021 membership year. Capitol Club Platinum Qualifying Donors shall receive a minimum of five (5) entries into the Sweepstakes.
 - Capitol Club Gold Donors are (a) those non-resident/non-medical student members of the Restricted Class who made a minimum Qualifying Donation of a thousand dollars (\$1,000) for the 2021 membership year; and (b) those resident/medical student members of the Restricted Class who made a minimum Qualifying Donation of five hundred dollars (\$500) for the 2021 membership year. Capitol Club Gold Qualifying Donors shall each receive a minimum of two (2) entries into the Sweepstakes.
 - Capitol Club Silver Donors are (a) those non-resident/non-medical student members of the Restricted Class who made a minimum Qualifying Donation of five hundred dollars (\$500) for the 2021 membership year; and (b) those resident/medical student members of the Restricted Class who made a minimum Qualifying Donation of two hundred fifty dollars (\$250) for the 2021 membership year. Capitol Club Silver Qualifying Donors shall each receive a minimum of one (1) entry into the Sweepstakes.**NO PURCHASE NECESSARY.** As an alternate method of entry, on a plain 3"x 5" card, legibly handprint with the words "*Promoting the Art and Science of Medicine and the Betterment of Public Health*" and your name, phone number and email address. Alternate-method entrants shall receive one (1) entry into the Sweepstakes. Then, mail the 3"x 5" card in a first-class, stamped envelope to the American Medical Political Action Committee, Republic Square 1, 25 Massachusetts Avenue, NW, #600, Washington, D.C. 20001, Attention: Nicole Lonetto, Sweepstakes Director. No copies, facsimile, computer generated, or mechanically reproduced, illegible, or incomplete entries will be accepted. Sponsor is not responsible for lost, late, illegible, misdirected, mutilated, incomplete, or postage-due mail/entries. Each entrant is responsible to keep Sponsor advised of any change of email, mailing address and/or telephone number of entrant. All card entries must be received before the Deadline to be eligible for the Sweepstakes. All entries will become the property of the Sponsor and will not be returned. Index card entries may be submitted without making a contribution to AMPAC if entries are submitted to AMPAC before 5:00 p.m. Eastern Time on Friday, November 5, 2021.

Members of the Restricted Class include individuals who are 18 years or older and are:

- Members of the American Medical Association; or
- Members of a state medical association; or
- Members of a county medical association, or
- Family members of individuals in categories (a), (b) or (c) above.

Employees of the American Medical Association (and their immediate family members) are not eligible to participate.

- Contributions are not deductible for income tax purposes. Contributions to AMPAC are voluntary and are used for political purposes. You may refuse to contribute without reprisal and AMPAC, the American Medical Association or any affiliated state medical associations will not favor or disfavor any member because of the amount contributed. Individuals who have previously contributed to AMPAC may make additional donations so long as that individual's total contribution for 2021 membership year does not exceed Five Thousand Dollars (\$5,000).
- The Winner will be determined in a random drawing from all eligible entries on Tuesday, November 9, 2021 at the AMA's Washington, DC Headquarters ("Winners"). The Winners will be announced during the AMA's Interim meeting in Orlando, Florida by the AMPAC Chair during the Capitol Club event. The announcement will take place at the Walt Disney World Swan and Dolphin Resort, 1500 Epcot Resorts Blvd, Orlando, FL 32830. Sweepstakes entrants need not be present to win.
- If Winners are not present during the announcement, Winners will be notified by a certified mailing (return receipt requested) sent to Winner's last known address within five (5) business days of the Sweepstakes drawing. No prize substitutions will be available. If the prize is not accepted within ten (10) calendar days after receipt of notification, the prize will be forfeited and awarded to an alternate winner.
- Odds of winning will be determined by the total number of Sweepstakes entries submitted before the drawing by the Deadline.
- Winners will be required to sign and return the AMPAC-provided Affidavit of Eligibility and Liability/Publicity Release form, within the ten (10) calendar day window before collecting his/her prize or the prize will be forfeited. Guest accompanying Winner ("Travel Companion") must sign and return an Affidavit of Eligibility and Liability/Publicity Release prior to travel.

Any difference between approximate cash value and actual value will not be awarded. Airport and/or airline are to be selected by Sponsor. Exact travel dates and arrangements subject to availability.
