American Medical Political Action Committee (“Sponsor”)

AMPAC’s Cheers to 65 Years Anniversary Sweepstakes (“Sweepstakes”)

1. Eligibility

AMPAC’s “65th Anniversary Sweepstakes (the “Sweepstakes”) is open to all current employees of the American Medical Association (the “AMA”) who are eligible to make a contribution to AMPAC. That group consists of AMA exempt salaried employees who have “policymaking, managerial, professional, or supervisory responsibilities.” These definitions and limitations are imposed by 52 U.S.C. 30118(b)(4)(D)(7); 11 C.F.R. § 114.1(c) and enforced by the Federal Election Commission.

Employees of affiliates of the AMA as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to enter or win. AMA Senior Management Group employees are not eligible to win. All federal, state, and local laws apply. **Void where prohibited.** The decisions of the Sponsor on all matters relating to this Sweepstakes are final in all respects.

2. Sponsor and Promoter

3. Agreement to Official Rules

Participation in the Sweepstakes constitutes entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

4. Sweepstakes Period

Qualifying Contributions are those contributions to the AMPAC Fund for the 2026 membership year delivered to a designated AMPAC agent in the Washington, DC Headquarters by 5:00 p.m. Eastern Time, Monday, June 1, 2026 (“Deadline”).

5. How to Enter

Qualifying Contributions will be automatically entered in the sweepstakes drawing and allocated based on the donation amount as outlined below. Qualifying Contributions are those contributions to the AMPAC Fund for the 2026 membership year delivered to a designated AMPAC agent in the Washington, DC Headquarters by 5:00 p.m. Eastern Time, Monday, June 1, 2026 (“Deadline”). Sweepstakes entries shall be allocated as follows: Capitol Club Diamond donors are employees who made a minimum Qualifying Donation of five thousand dollars (\$5,000) for the 2026 membership year. Capitol Club Diamond Donors will receive six (6) entries into the Sweepstakes. Capitol Club Platinum Donors are employees who made a minimum Qualifying Donation of two thousand five hundred dollars (\$2,500) for the 2026 membership year. Capitol Club Platinum Donors will receive four (4) entries into the Sweepstakes. Capitol Club Gold Donors are employees who made a minimum Qualifying Donation of one thousand dollars (\$1,000) for the 2026 membership year. Capitol Club Gold Donors will receive three (3) entries into the Sweepstakes. Capitol Club Silver Donors are employees who made a minimum Qualifying Donation of five hundred dollars (\$500) for the 2026 membership year. Capitol Club Silver Donors will receive two (2) entries into the Sweepstakes. Sustaining Donors are employees who made a minimum Qualifying Donation of one hundred dollars (\$100) for the 2026 membership year. Sustaining Donors will receive one (1) entry into the Sweepstakes.

Contributions are not deductible for income tax purposes. Contributions to AMPAC are voluntary and are used for political purposes. You may refuse to contribute without reprisal and AMPAC, the American Medical Association, or any affiliated state medical associations will not favor or disfavor any member because of the amount contributed. Individuals who have previously contributed to AMPAC may make additional donations so long as that individual’s total contribution for 2026 membership year does not exceed Five Thousand Dollars (\$5,000).

NO PURCHASE NECESSARY. As an alternate method of entry, legibly hand-print on a plain 3”x 5” card the words “Promoting the Art and Science of Medicine and the Betterment of Public Health” and your name, phone number, and email address. Alternate-method entrants shall receive one (1) entry into the Sweepstakes. Then, mail the 3”x 5” card in a first-class, stamped envelope to the American Medical Political Action Committee, Republic Square 1, 25 Massachusetts Avenue, NW, #600, Washington, D.C. 20001, Attention: Nicole Lonetto, Sweepstakes Director. No copies, facsimile, computer generated, or mechanically reproduced, illegible, or incomplete entries will be accepted. Sponsor is not responsible for lost, late, illegible, misdirect, mutilated, incomplete, or postage-due mail/entries. Each entrant is responsible to keep Sponsor advised of any change of email, mailing address, and/or telephone number of entrant. All card entries must be received before the Deadline to be eligible for the Sweepstakes. All entries will become the property of the Sponsor and will not be returned. Index card entries may be submitted without contributing to AMPAC if entries are received by AMPAC before 5:00 p.m. Eastern Time on Monday, June 1, 2026.

6. Prize Drawing

The winners will be determined in a random drawing from all eligible entries from AMA employees from the Chicago and Washington, DC offices including remote employees on June 2, 2026, at the AMA's Washington, DC Headquarters. The winners will be selected in two separate random drawings, one drawing for the AMA Chicago office ("Chicago Grand Prize") and one drawing for the Washington, DC office ("Washington, DC Grand Prize"). The odds of being selected depend on the number of entries received.

7. Winner Notification

The winners will be notified via email within one (1) day of the drawing. If the winner does not respond within three (3) days after the date of the first attempt to contact him/her, the prize will be forfeited and awarded to an alternate winner. Sweepstakes entrants need not be present to win.

Refusal or failure to sign and return the Affidavit of Eligibility and Liability/Publicity Release Form and applicable tax forms within fourteen (14) days from first attempted notification will result in forfeiture of the prize and the prize will be awarded to an alternate winner. Prize(s) will be awarded within thirty (30) days after receipt of Affidavit/Release. If Affidavit/Release is returned as undeliverable, it will result in disqualification, and the corresponding prize will be awarded to an alternate winner. If a prize is forfeited for any reason whatsoever, the forfeited prize will be awarded to an alternate winner. 11. Release and Limitations of Liability

By participating in this Sweepstakes, entrants agree to release Sponsor, and any other organizations affiliated with the sponsorship, fulfillment, administration, prize support, advertisement or promotion of this Sweepstakes (such as, not limited to, any providers of the prize, and any social media outlets that Sponsor may use to promote the Sweepstakes including, but not limited to, Facebook and Twitter), and each of the respective parents, agents, affiliates, subsidiaries, advertising and promotion agencies, and prize suppliers, each of their respective officers, directors, agents, representatives, and employees from any and all actions, claims, injury, loss, or damage arising in any manner, in whole or in part, directly or indirectly, from participation in this Sweepstakes and/or acceptance or use of the prize.
