PARTICIPATION COMPETITION



State Delegations and AMA Councils are invited to compete for the prestigious **AMPAC Leadership Cup!**

STATE DELEGATIONS



The State HOD competition is structured with four (4) groups based on the number of delegates/alternate delegates for each state, categorized as: Big, Large, Medium, and Small.



Four (4) trophies will be awarded – one to the state in each group that achieves 100% AMPAC HOD participation, with additional criteria applied as needed to determine a single winner per group.



Each trophy will be engraved annually with the winning state to be displayed during their Delegation meeting at the AMA's Interim Meeting.

CRITERIA

The winner in each group will be determined using the criteria below. The HOD delegation includes physician/resident/student delegates and alternate delegates.

If more than one state has 100% AMPAC participation, the winning state will be determined using the following criteria in order:

- 1 A minimum of 50% participation at the Capitol Club level
- 2 Highest per-capita dollar amount
- 3 Most Capitol Club Diamond members

AMA COUNCILS



The seven AMA Councils will engage in a participation competition with each other.



One trophy will be awarded to the AMA Council that achieves 100% AMPAC participation, with additional criteria applied as needed to determine a single winner.



The trophy will be engraved annually with the winning Council to be displayed at their Council meeting at the AMA's Interim Meeting.

CRITERIA

The AMA Council winner will be determined using the criteria below.

If more than one Council has 100% AMPAC participation, the winning Council will be determined using the following criteria in order:

- 1 A minimum of 50% participation at the Capitol Club level
- 2 Highest per-capita dollar amount
- 3 Most Capitol Club Diamond members
